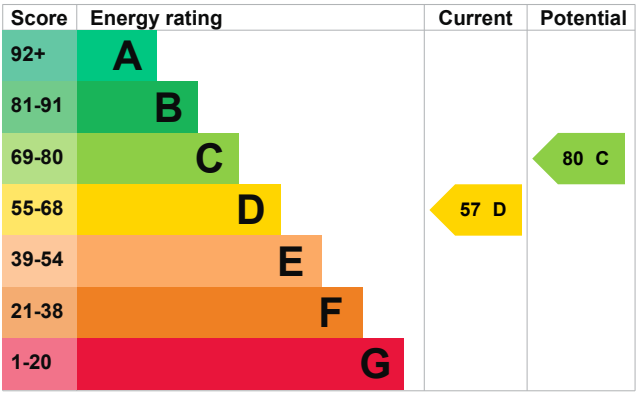

Primary energy use

The primary energy use for this property per year is 293 kilowatt hours per square metre (kWh/m²).

How this affects your energy bills
